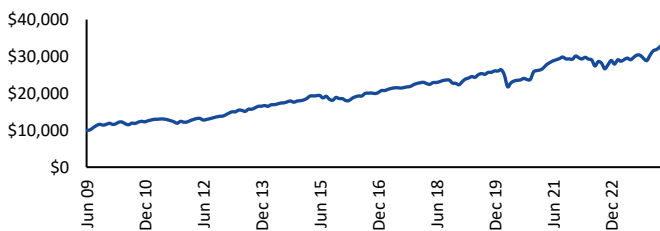

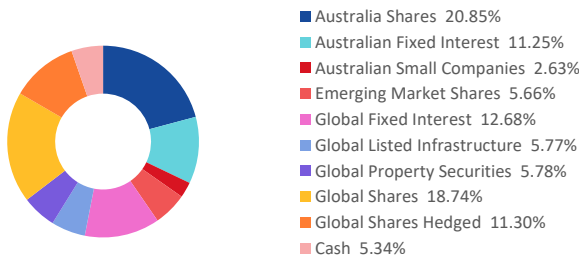

Asset allocation



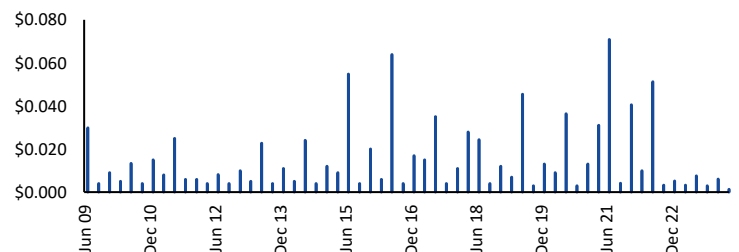

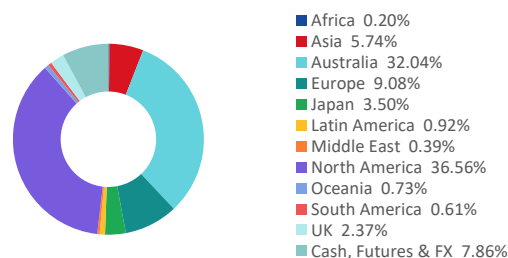
