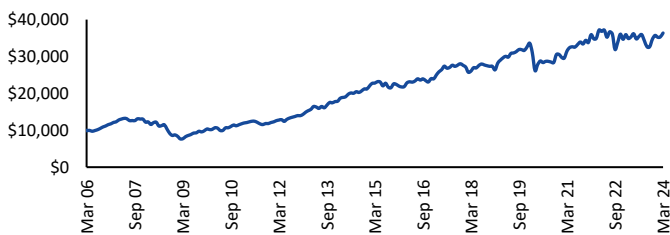

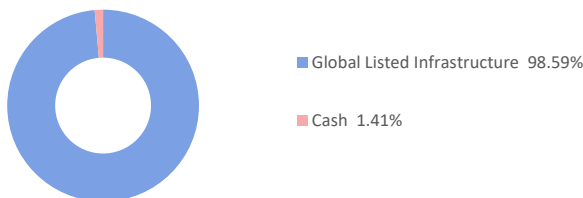

Asset allocation



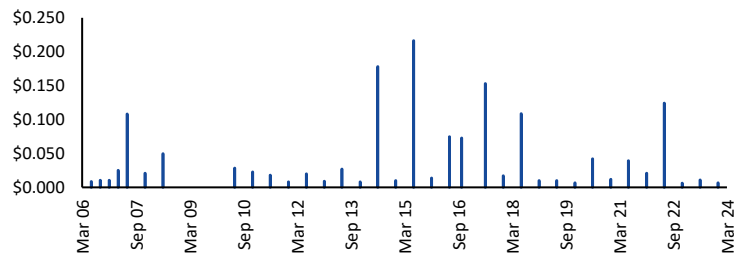

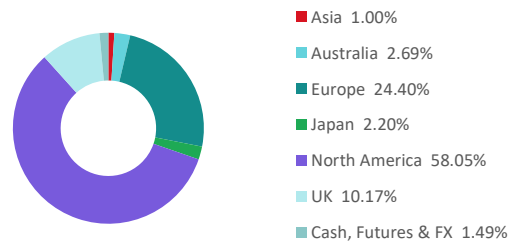
