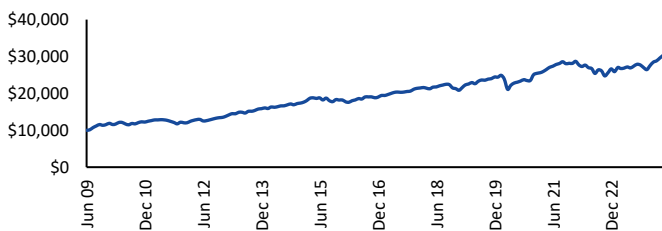

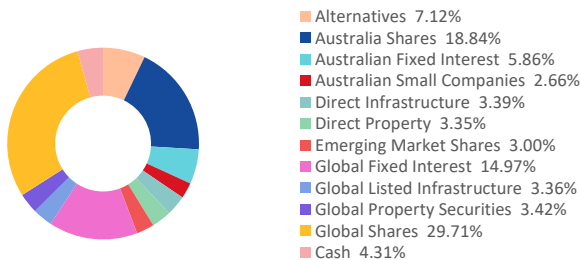

### Asset allocation



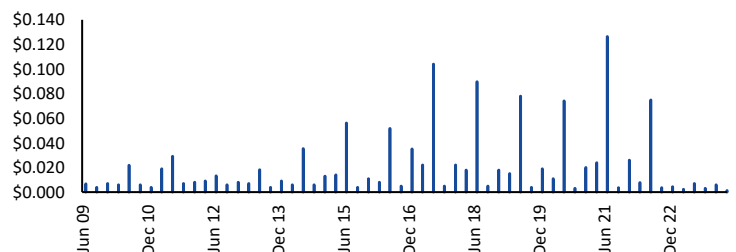

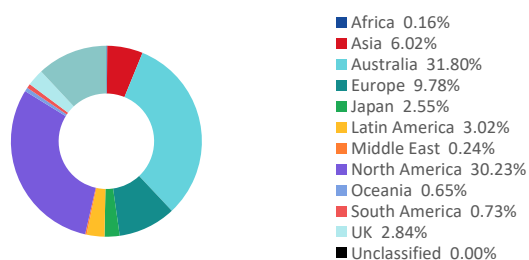
